Electronic bids must be submitted to the office **Harinagara Rural Municipality , Harinagara, Sunsari, Province -1, Nepal** through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np) on or before **12:00 Noon** on 31<sup>st</sup> day of publication of notice. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm** on **31st** day of publication of notice at the Harinagara Rural Municipality Office, **Harinagara, Sunsari, Province -1, Nepal**. Bids must be valid for a period of **90 (Ninety) days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting as specified below which shall be valid for 30 days beyond the validity period of the bid. Non submission of the hard copy by the bidders within the specified time shall be considered as non-responsive and may cause forfeiture of bid security.
10. Matters not covered by this notice shall be in accordance with Bid document, PPA and PPR.

  - a) The prospective bidder should be **technically & financially** sound registered with **Govt. of Nepal for last 10 years** in good standing
  - b) Average Annual Turnover and minimum work experience is specified in the bid documents.
